VENDORS WILL RECEIVE designated vendor space, show program, listing in show program (if reservation made two weeks before the show) and web site link.

COST: Vendor space will be provided no charge. Sponsorship and prize donations are gratefully accepted.

SET UP is between 12:00 am and 6:00 pm the day before the show (May 15, 2019). Vendors will provide their own materials, equipment and labour in order to set up their booth and acknowledge that National Capital Dressage Inc. will not provide any tents, water hoses, extension cords or any other equipment. Vendor booth placement will be acontrolled by National Capital Dressage Inc. and Vendors agree not to set up any booth anywhere on the show site other than the location specified. Vehicles must be removed from Vendor site by 7:00 am each show day.

REMOVAL: Vendors agree to remove their booths as well as all materials, equipment and other property by 8:00 pm on Sunday, May 19, 2019, at the conclusion of the Event. Vendors must leave the portion of the Facilities occupied by their booth in the same condition as it was in prior to the Event.

Hours of operation: Vendors are requested to open by 9:00 am each day of the show and close no earlier than 4:30 pm.

LIABILITY INSURANCE: All Vendors are required to obtain their own insurance.
